Mayor Wiss called the regular business meeting to order at 7:03 p.m. The Pledge of Allegiance was recited, and roll was called.

Kraft moved to approve the March 7, 2024 Special Meeting minutes. Riggs 2nd. Motion passed 4-0.

Warren moved to approve the March 12, 2024 Special Meeting minutes. Riggs 2nd. Motion passed 4-0.
